Service Plan & Funding Agreement for the Year Ending September 30, 2025

Sun Valley Air Service Board ("SVASB") and **Mountain Rides Transportation Authority** (MRTA) hereby agree to advance a partnership into and through the year ending September 30, 2025, with MRTA providing fixed-route bus service to and from Friedman Memorial Airport (SUN), as detailed in the Service Plan, below, and SVASB providing funding to underwrite that service, as set forth in the Funding Consideration, below.

Transportation Services: Service Plan

Mountain Rides agrees to provide Fixed-Route Bus Transportation Service to and from the SUN Bus Stop as follows:

A. Via MRTA's Valley Route:

- Daily, year-round service.
- Direct service, without a passenger transfer from one bus to another, to and from SUN, from and to all northbound and southbound bus stops served by MRTA's Valley Route.
- Approximate SUN Bus Stop times, daily:
 - Southbound at SUN: 11:35AM; 12:35PM; 10:35PM; 12:35AM.
 - Northbound at SUN: 1:15PM; 2:15PM; 10:45PM.

B. Via MRTA's Hailey Route:

- Weekdays (Monday through Friday), year-round service.
- Direct service, without a passenger transfer from one bus to another, to and from SUN, from and to all northbound and southbound bus stops served by MRTA's Hailley Route.
- Service, with a passenger transfer to/from MRTA's Valley Route, to and from SUN, from and to all northbound and southbound bus stops served by MRTA's Valley Route.
- Approximate SUN Bus Stop times, Monday through Friday:
 - Southbound at SUN: 8:35AM; 9:35AM; 10:35AM; 11:35AM; 12:35PM; 1:35PM; 2:35PM; 3:40PM.
 - Northbound at SUN: 8:08AM; 9:08AM; 10:08AM; 11:08AM; 12:08PM; 1:08PM; 2:08PM; 3:15PM.

Funding Consideration

In consideration of Mountain Rides' providing the Transportation Services set forth above, SVASB agrees to pay Mountain Rides Transportation Authority the sum of \$105,000. Mountain Rides Transportation Authority agrees to submit an invoice at least thirty (30) days in advance of each payment due date and the Sun Valley Air Service Board agrees to make payments according to the following schedule: a \$55,000 payment due on the 30th day of November 2024, and a \$50,000 payment due on the 31st day of May 2025.

Agreed and Accepted:
